Reminders of 2026 / 2027 Interim Admission Application

1. An application form should be submitted **in person at the School Office on 1<sup>st</sup> Floor.**
2. Please submit the completed application form with supporting documents and application fee of \$75 (by cheque only, payable to The Incorporated Management Committee of Po Leung Kuk Hong Kong Taoist Association Yuen Yuen Primary School).  
*\*\*Online applicants do not need to submit the application form again.*
3. Please submit the application form with the following documents (A4 paper size) in person.
  - The completed application form and a recent photo attached;
  - **One photocopy** of applicant's birth registration documents;  
(In case of absence of HK Birth Certificate, photocopies of valid supporting documents certifying the child's right of abode in HK are required.);
  - **One photocopy** of report card or comprehensive report of the latest semester;
  - **Certificate photocopies (maximum 5 pages)** of extra-curricular activity or any other special strength (if applicable).

All the submitted or contained information must be true and correct. Otherwise, the application will be assumed disqualified and the applicant may bear criminal liabilities.

## 2026/ 2027 插班生入學申請須知

1. 請親身到本校一樓校務處遞交申請表。
2. 請把已填妥的申請表格，連同有關資料及報名費 \$75 (只接受支票，支票抬頭:保良局香港道教聯合會圓玄小學法團校董會) 繳交。  
\*\*如已完成網上申請之學生無須再遞交表格。
3. 申請人須連同下列文件交回或郵寄到本校（尺寸以 A4 紙為準）：
  - 填妥並已貼上近照之申請表；
  - 出生證明副本一份(如未能提供香港出生證明書，則必須提供有效的香港居留權證明文件)；
  - 最近一個學期之成績表/學期總評估表副本一份；
  - 課外活動或其他特別專長證明文件副本，以不多於五頁為限 (如適用)。所有遞交或填報之資料必須屬實，否則本校有權取消 貴子弟之申請資格，及保留對申請者追究刑事責任之權利。
4. 若 貴子弟所用的母語並非華語，本校將安排 貴子弟就讀「非華語中文課程」。請在表格內註明選擇報讀「本地中文課程」或是「非華語中文課程」。學校將與選擇就讀「非華語中文課程」的申請人聯絡，並根據 貴子弟的家庭背景，再為他們安排合適的中文課程。

## School Fee Remission Scheme 2025-2026

In order to relieve the financial burden of students' families with economic hardship, the school is going to provide the fee remission scheme to assist. Applicants who are eligible to the criteria can apply the scheme.

Details as follow:

### 1. Aim

To relieve the financial burden of students' families with economic hardship.

### 2. Eligibility Criteria

- 2.1 The applicant must be a parent / statutory guardian of a current registered student of the school; and
- 2.2 The applicant must pass the means test.

### 3. Method of Assessment (Means Test)

The school will use the "Adjusted Family Income" (AFI) mechanism as the means test to assess the eligibility of a family for the scheme and the level of assistance. The formula is as follows:

$$\text{AFI} = \frac{\text{Gross Annual Income of the family}}{\text{Number of family members} + 1}$$

- 3.1 Gross annual income of the family includes the annual income of the applicant and spouse (if applicable); 30% of the annual income of unmarried child / children residing with the family (if applicable); and the contribution from relatives / friends (if applicable).
- 3.2 The members of a family normally refer to the applicant, the spouse, unmarried child / children residing with the family and the dependent parent(s) of the family.
- 3.3 For single-parent families of 2-3 members, will be regarded as families of 3-4 members before taking assessment.

### 4. Level of Assistance

The AFI eligibility benchmarks for various levels of assistance are listed below. Please note that the AFI is not the average monthly income of a family.

AFI Groups between (HK\$)	Level of Assistance
0 — 45,429	*Full (100%)
45,430 — 87,846	Half (50%)
> 87,846	Ineligible (Nil)

\*AFI thresholds for full level of assistance for families of 3 and 4 members are \$54,999 and \$50,600 respectively.

## 2025-2026 年度學費減免計劃

為援助有經濟需要的學生，為他們提供學費減免援助，本校將會推出學費減免計劃供符合援助資格的申請者參加。

細則如下：

1. 計劃目的 援助有經濟需要的學生，為他們提供學費減免。

### 2. 申請資格

- 2.1 申請者為本學年在校的註冊學生之家長或法定監護人；及
- 2.2 申請者必須通過家庭入息審查。

### 3. 評審方法（入息審查）

本校是採用「調整後家庭收入」機制進行入息審查，以評定申請人的資助資格及幅度。「調整後家庭收入」機制所採用的算式如下：

$$\text{調整後家庭收入} = \frac{\text{家庭全年總收入}}{\text{家庭成員人數} + 1}$$

- 3.1 家庭全年總收入包括申請人及配偶（如適用）的全年收入，與申請人家庭同住的未婚子女的全年收入的30%（如適用），以及親友給予的津助（如適用）。
- 3.2 家庭成員通常是指申請人、申請人的配偶、與申請人家庭同住的未婚子女及受供養父母。
- 3.3 2人和3人的單親家庭，將被視為3人和4人家庭後再按公式計算。

### 4. 減免幅度

- 4.1 按「調整後家庭收入」訂定申請人學費減免資格的計算如下表所示。
- 4.2 請注意，「調整後家庭收入」並非代表平均每月家庭收入。

0 — 45,429	*全免 (100%)
45,430 — 87,846	半免 (50%)

\*3人及4人家庭可獲全免學費的「調整後家庭收入」上限分別為54,999元和50,600元。
